## COTTON PEST MANAGEMENT NEWSLETTER #1

**COTTON SITUATION:** The Georgia Weekly Crop Progress and Condition Report for the week ending April 24<sup>th</sup> listed the crop as 7 percent planted with is similar to the five year average of 6 percent.

**INSECT SITUATION:** Relatively few fields have emerged but we have received reports that thrips populations are relatively high which is normal for early planted fields. Tim Flanders, CEC in Berrien County, reported that grasshoppers were numerous in some localized reduced tillage fields. Grasshoppers, although a sporadic, localized and uncommon pest of seedling cotton, are more likely to be an issue following a dry winter.

**EPA Seeking Comment on Aldicarb Registration by April 29<sup>th</sup>:** EPA has received an application to register a pesticide product containing the active ingredient aldicarb. Pursuant to the provisions of section 3 (c) (4) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), EPA has provided notice of receipt and opportunity to comment on this application in the Federal Register Volume 76, Number 61 (Pages 17645-17646). Comments on this aldicarb registration should be directed to docket ID number EPA-HQ-OPP-2010-1021 and must be received by EPA on or before April 29, 2011.
